1. Introduction

Our Lady and St Patrick's College, Knock is committed to providing a positive, well-ordered and safe environment in which effective learning and teaching can take place. The College uniform helps identify our students as part of our College community. The results of extensive consultations with parents and students reveal that our uniform provides a strong sense of identify and belonging. It also serves to reduce social and financial pressure on our students. As representatives of Our Lady and St Patrick's College, Knock, students are expected to maintain high standards of uniform throughout the academic year.

The School Uniforms (Guidelines and Allowances) Act (Northern Ireland) 2026 (19/02/26) requires the Department of Education (DE) to issue official guidelines for school uniform policies. This policy reflects School Uniforms Guidelines (DE - 20/02/26), including Guideline 12 (See Appendix 1 - Page 8-16), and other guidance listed in Appendix 2 (Page 17). It is ratified by the Board of Governors and implemented by the students and staff of the College.

2. Aims

This Uniform Policy aims to:

- Help identify our students as part of our College community and encourage a sense of belonging and support;
- Instil pride in our students as representatives and ambassadors of the College;
- Promote a collective sense of responsibility among all students and staff for upholding high standards of behaviour and presentation;
- Create a positive, well-ordered and safe environment in which effective learning and teaching can take place;
- Develop students' self-discipline and sense of responsibility;
- Provide value for money for parents and protect students from social pressures to dress in a particular way;
- Be fair, inclusive and sensitive to the financial circumstance of families.

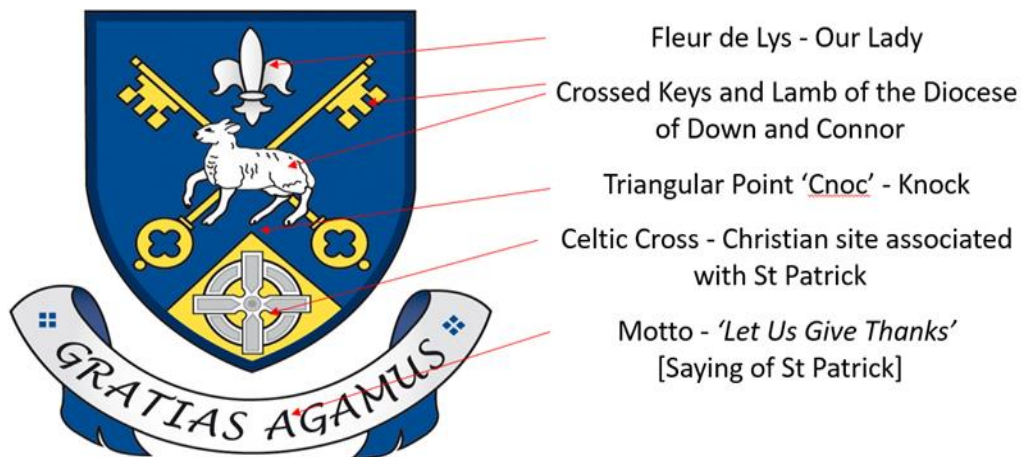
4. Uniform Grants

5. PTA Uniform Upcycling Initiative (Uniform Bank)

Affordability and sustainability are at the heart of the College Uniform Policy. To assist families, the PTA runs a Uniform Upcycling initiative throughout the year. Parents are informed of the dates of a 'pop-up shop' and items are also available from Reception at any time. Parents are encouraged to be part of the PTA Uniform Upcycling initiative and to donate to, and purchase from, this very worthwhile initiative.

7. College Uniform

College Regulation Uniform - Compulsory Items

- Black blazer with the sew on College crest
- Traditional black school trousers (full length and regular fit) to be worn with plain black socks or Regulation drop waist skirt, mid-grey, stitch down, all round pleat (65/35) with adjustable waist (1880 brand), worn on/below the knee with grey knee-length socks or plain black opaque tights
- Plain white long or short-sleeved school shirt (top button fastened and tucked into trousers/skirt)
- College tie
- Plain black low-heeled school shoes (not trainers). Heels on shoes should be a maximum of 3 cm. Only black laces are permitted.

College Regulation Uniform - Optional Items

- Grey or black V-neck knitted jumper with College colours
- College scarf or plain black scarf (non-branded)
- Plain black or grey woollen hat (non-branded) and/or a plain black or grey coat (non-branded) which may be worn whilst travelling to and from the College and then removed on entering the school building

College Regulation PE Uniform - Compulsory Items

- College PE top (O'Neill's brand) or plain black t-shirt (non-branded)
- College shorts or skort (O'Neill's brand) or plain black shorts (non-branded)
- College socks (O'Neill's brand) or plain black or white ankle socks (non-branded)
- Trainers (laced, non-marking soles)

College Regulation PE Uniform - Optional Items

- College half-zip (O'Neill's brand)
- College bottoms or leggings (O'Neill's brand) or plain black bottoms or leggings (non-branded)

8. Rules for Uniform and Appearance

- Students must wear regulation uniform in the College, going to and from the College and at all College functions and representative events, unless otherwise permitted by the Principal. Students must adhere to the College regulations regarding their personal appearance as stated in the Rules for Uniform and Appearance.
- All items of uniform should be labelled with the student's name. Students who lose items of uniform should check Lost Property in the Dining Hall.
- All students must wear a blazer coming to and going from the College.
- Black denim-type jeans are not acceptable.
- If students wish to wear a belt, it must be plain black.
- Subtle make-up is permitted in Year 10-14.
- For health and safety reasons, long hair must be safely tied back for work in a Science laboratory or Technology workshop.
- Students may wear one plain ring and/or a plain pair of studs/sleepers (one in each ear lobe). Nose piercings and other piercings must be replaced with a clear stud during the school day. No other jewellery may be worn. Jewellery must be removed during PE classes. Students who wish to have new piercings should therefore do so at the beginning of the summer holidays.
- All Upper School students must wear the Sixth Form crest on their blazers.
- Any item of clothing or jewellery worn against College uniform regulations is liable to be confiscated, to be returned at the end of the school day.
- An explanatory note from a parent must be provided if a student cannot wear College Regulation Uniform.
- The College reserves the right to issue further guidance to students during the school year in the event of fashion trends impacting adversely on student appearance.

These rules are subject to amendment by the Principal. In all cases, the Principal reserves the right to apply what she considers to be the most appropriate sanctions in relation to non-compliance with College Uniform Policy.

9. Representative Sport

- The College endeavours to provide school-owned kits for all representative teams.
- If students do not have a College half-zip (O'Neill's brand), they should speak with the respective Head of PE who will lend them the item, if necessary, for representative sport.
- If students are involved in a representative sporting activity at the beginning of the school day, they may come to school in their College half-zip (O'Neill's brand) and then change into College Regulation Uniform before returning to class.
- Students returning home after extra-curricular sporting activities are permitted to wear either College Regulation Uniform or College Regulation PE Uniform.
- Mouth guards are compulsory for camogie, Gaelic and hurling matches.

10. Inclement Weather

- In inclement weather a plain black or grey woollen hat (non-branded) and/or a plain black or grey coat (non-branded) may be worn whilst travelling to and from the College and then removed on entering the school building.
- If necessary, students are encouraged to wear additional layers under their school shirt.
- Students may wear a plain white long or short-sleeved school shirt.

11. Safe Travel: High Visibility Items and/or Reflective Panels

School uniforms can often be quite dark, making it difficult for students to be seen by drivers during the winter months, particularly on rural roads when travelling to and from school.

Parents are asked to ensure that students wear high visibility items and/or reflective panels on their schoolbags when making their way to and from the College.

12. Roles and Responsibilities

Students are expected to take pride in their appearance as representatives of Our Lady and St Patrick's College, Knock. When in uniform, all students are ambassadors of the College and it is important that they adhere to school uniform standards in the College, going to and from the College and at all College functions and representative events.

The Student Council, Mentors, Senior Prefects and Head Team are role models for the student body. They are responsible for upholding high standards of uniform and representing the views of the students of Knock.

College Staff are responsible for upholding high standards of uniform. They should record poor uniform standards as per College procedures and refer any student whose uniform is persistently unsatisfactory to the Tutor.

Tutors/Heads of Year/Heads of School/Vice Principals have particular responsibility for maintaining high standards of uniform in their respective groups. They should follow the procedures outlined in the Positive Behaviour Policy to ensure high standards of uniform are achieved.

Parents/Carers are expected to ensure that their child wears full College uniform and abides by College rules. Close cooperation between home and school is essential in order to maintain high standards of uniform. Parents are reminded that on accepting a place for their child(ren) in the College, they were advised that it is our expectation that parents support College staff when they implement College policies.

13. Compliance with Human Rights and Equality Legislation

Uniform policies must comply with relevant human rights and equality legislation. We, as a College, are aware of the laws which protect individuals from unlawful discrimination, including human rights, race, sex and disability. For students with SEN or disabilities, particularly where these manifest as sensory issues, we will make reasonable adjustments that will not generate additional costs over the uniform requirements for other students. Temporary exemptions can also be made for a student who has sustained a broken limb.

Any request for an adjustment to the compulsory aspects of the uniform should be made in writing to the Vice Principal (Pastoral Care) for consideration.

14. Exceptions on the Grounds of Religious Beliefs

Adjustments to these regulations on the grounds of religious beliefs may be permitted. Any request for an adjustment should be made in writing to the Vice Principal (Pastoral Care) for consideration.

15. Non-Compliance with College Uniform Policy

Where a student is not adhering to College Uniform Policy, the Pastoral Team will make discreet and sensitive enquiries as to why this is the case and provide assistance if required (i.e. due to affordability issues).

If there is no valid reason, designated staff will apply appropriate sanctions as outlined in the Positive Behaviour Policy. As a community of learners, we rely on working in close partnership with home to ensure high standards of uniform are maintained for all our learners. In the unlikely event that a student is not wearing the uniform correctly and the matter has not been satisfactorily resolved, parents will be required to attend a meeting with the Vice Principal (Pastoral Care) to discuss the matter further.

16. Transition Period When Changing Uniform Requirements

The College is committed to permitting reasonable transition periods when changing uniform requirements. Consideration will be given to the Key Stage of a student. For example, as stated in DE School Uniforms Guidelines, it is reasonable that Year 8 students should be able to purchase new uniform items, while it is unreasonable that Year 14 students should be required to purchase same.

17. Review

The Vice Principal (Pastoral Care) will review this Uniform Policy every three years in consultation with students and parents.

18. How to Raise a Concern or Make a Complaint about the Administration of this Policy

If you have a concern or complaint about the administration of this policy, please contact Ms McCarthy, Vice Principal, in the first instance. If necessary, you may then access and follow the College's Complaints Procedure which is available on the College website at www.knock.co.uk. Should you remain dissatisfied with the College's response after completing the internal complaints procedure, you can bring your complaint to the Northern Ireland Public Services Ombudsman within six months. School Uniforms Guidelines - Guideline 12

The manager of a school must publish and keep-up-to date the following information on their website:

1. The College's Uniform Policy

The College's Uniform Policy is published on the College website at www.knock.co.uk . It was approved by the Board of Governors on 10/03/26.

2. At least once a year, any information about an agreement described under Guideline 11, unless it is a pre-commencement agreement

Guideline 11 states - Uniforms must generally be available from multiple suppliers to ensure accessibility and affordability for families. As a minimum requirement, at least one supplier must be independent meaning they do not have any formal, contractual, or informal agreement with the school to sell uniforms. An exception to this requirement may only be made if the school manager publishes a value for money declaration.

College Regulation Uniform is available from multiple uniform suppliers (Gowdys, Roberts School Wear, Truly Fare, Warnocks) which are all independent and do not have any formal, contractual, or informal agreement with the school to sell College Regulation Uniform. Generic items (trousers, shirts, etc.) can be purchased on the high street or online. The College does not have any formal, contractual or informal agreement with any high street or online suppliers to provide College Regulation Uniform.

College Regulation PE Uniform (branded) may be purchased from O'Neill's or College Regulation PE Uniform (non-branded) can be purchased on the high street or online. O'Neill's has a pre-commencement agreement with the College to sell College Regulation PE Uniform (branded) from 01/01/25 - 21/12/29. College Regulation PE Uniform (non-branded - plain black t-shirt, plain black shorts, plain black or white ankle socks, plain black bottoms or leggings) may be purchased on the high street or online. The College does not have any formal, contractual or informal agreement with any high street or online suppliers to provide non-branded items.

3. The value for money declaration, if any, is entered into on a single and/or limited uniform supplier basis under Guideline 11

N/A. Whilst College Regulation PE Uniform (branded) may be purchased from O'Neill's, College Regulation PE Uniform (non-branded) may be purchased from various suppliers on the high street or online.

4. Information about, including the outcome of, the College's consultation with parents, students and anyone else consulted

Consultation with Parents:

- All parents were consulted by online survey in December 2025.
- 296 responses were received.
- Parents overwhelmingly support having a uniform: 87% say it promotes identity, belonging and community.
- 59% say the uniform is comfortable/practical; 27% disagree.
- 56% feel the uniform promotes equality; 30% neutral; 14% disagree.
- 80% rated the quality of the O'Neill's kit positively.
- 51% favour unbranded or part-branded PE kit; 30% against.
- PTA Upcycling: 43% donate, but only 20% buy.

Improvements - What Parents Want Most - Outcome (in italics)

- A coat/rainproof layer added or permitted. *This has always been permitted.*
- Cheaper PE kit - especially bottoms. *This has been actioned from March 2026.*
- More unbranded choices, especially for PE. *This has been actioned from March 2026.*
- Option to wear PE kit all day on PE days. *This has not been actioned as College Regulation PE Uniform - Compulsory Items are only shorts, a top and socks which are unsuitable for all seasons.*
- Simpler skirt option. *This has not been actioned. The skirt is already a plain colour, long-lasting and provides value for money.*
- Introduce summer short sleeve options. *This has always been permitted.*
- Change girls' white PE top to a darker unisex colour. *This has been actioned from March 2026.*
- Encourage more girls to wear trousers if they wish. *All students have the option of wearing trousers or a skirt.*
- Consider unifying jumper colours. *This has been actioned from March 2026. The jumper is also an optional item.*

Consultation with Students:

- All students were consulted by online survey in December 2025.
- 219 responses were received.
- Students recognise the purpose of a uniform but are less positive than parents about how well the current uniform works in practice.
- 17% agree the uniform is practical for all seasons; 75% disagree.
- 27% agree that the uniform is comfortable and practical day-to-day, while over half disagree.
- 44% agree the uniform supports identity and community, while nearly one third disagree.
- 56% agree the uniform promotes inclusion (gender neutral approach).
- 48% agree the uniform is sustainable.
- 60% rated the quality of the O'Neill's kit positively; 55% enjoy wearing it.
- The girls' white PE top was criticised, as was the optional half-zip (too thin for winter).
- Students strongly support branded kit for representing the College (over 60%).
- At the same time, many favour unbranded or generic PE items for lessons, particularly lower body items.
- PTA Upcycling: 30% donate, but only 10% buy.

Improvements - What Students Want Most - Outcome (in italics)

- A coat/rainproof layer added or permitted. *This has always been permitted.*
- Introduce summer short sleeve options. *This has always been permitted.*
- Simpler skirt option. *This has not been actioned. The skirt is already a plain colour, long-lasting and provides value for money.*
- Change girls' white PE top to a darker unisex colour. *This has been actioned from March 2026.*
- Provide warmer PE layers (hoodies instead of thin half-zips). *This has not been actioned. The half-zip is an optional item and hoodies are kept for Leavers.*
- Allow PE kit on PE days, especially in KS3. *This has not been actioned as College Regulation PE Uniform - Compulsory Items are only shorts, a top and socks which are unsuitable for all seasons.*

5. The rationale for the requirements in terms of the uniform items and overall design which are set out in the uniform policy

College uniform aims to:

- Help identify our students as part of our College community and encourage a sense of belonging and support;
- Instil pride in our students as representatives and ambassadors of the College;
- Promote a collective sense of responsibility among all students and staff for upholding high standards of behaviour and presentation;
- Create a positive, well-ordered and safe environment in which effective learning and teaching can take place;
- Develop students' self-discipline and sense of responsibility;
- Provide value for money for parents and protect students from social pressures to dress in a particular way;
- Be fair, inclusive and sensitive to the financial circumstance of families.

The rationale for each uniform item and overall design is as follows:

- The College Crest contains: Fleur de Lys (to represent Our Lady); Celtic Cross (to represent a Christian site associated with St Patrick); Triangular Point 'Cnoc' (to represent Knock); Crossed Keys and Lamb of the Diocese of Down and Connor (as we are a Diocesan College); and the motto 'Gratias Agamus' – 'Let Us Give Thanks' (a saying of St Patrick).
- 'Value for money' is provided based on the availability of items from four uniform suppliers with other items available on the high street or online.
- 'Value for money' is also provided due to the durability of the blazer, skirt and College tie.
- Compulsory branded items are kept to a minimum. The blazer and College tie promote a sense of identity and are important for Child Protection/Safeguarding reasons to identify students clearly on and off site.
- PE branded items are optional and are kept to a minimum. They were introduced at the request of the Student Council. Non-branded PE items are also permitted.
- The rationale for each uniform item is provided on the table on the next page.
