1. Introduction

The College is committed to providing a positive, well-ordered and safe environment in which effective learning and teaching can take place. The uniform for Our Lady and St Patrick's College, Knock helps identify our students as part of our College community. As representatives of Our Lady and St Patrick's College, Knock, students are expected to maintain high standards of uniform throughout the academic year. This policy is ratified by the Board of Governors and implemented by the students and staff of the College.

2. Aims

This Uniform Policy aims to:

- Promote a collective sense of responsibility among all students and staff for upholding high standards of behaviour and presentation.
- Help identify our students as part of our College community and encourage a sense of belonging and support.
- Instil pride in our students as representatives and ambassadors of the College.
- Create a positive, well-ordered and safe environment in which effective learning and teaching can take place.
- Develop students' self-discipline and sense of responsibility.
- Provide value for money for parents and protect students from social pressures to dress in a particular way.

4. <u>Uniform Grants</u>

Families who receive benefits or are on low income could be entitled to uniform grants. The eligibility criteria are similar to those used for entitlement to free school meals. 5. PTA Uniform Upcycling

To assist families, the PTA runs a Uniform Upcycling initiative throughout the year. Parents are informed of the dates of a 'pop-up shop' and items are also available from Reception at any time.

6. College Uniform

College Regulation Uniform - Compulsory Items

- Black blazer with College crest
- Traditional black school trousers (full length and regular fit) to be worn with plain black socks, or
- Regulation drop waist skirt, mid-grey, stitch down, all round pleat (65/35) with adjustable waist (1880 brand), worn on/below the knee with grey knee-length socks or plain black opaque tights
- Plain white school shirt/blouse (top button fastened and tucked into trousers/skirt at all times)
- College tie
- Plain black low-heeled school shoes (maximum of 3 cm) (not trainers)

College Regulation Uniform - Optional Items

- Grey or black V-neck knitted jumper with College colours
- College scarf or plain black scarf
- A plain black or grey woollen hat

College Regulation PE Uniform (O'Neill's brand)

- College tracksuit (half-zip and bottoms or jeggings)
- College shorts or skort
- College PE top
- College socks or white ankle socks
- Trainers (laced, non-marking soles)

7. Rules for Uniform and Appearance

- Students must wear regulation uniform in the College, going to and from the College and at all
 College functions and representative events, unless otherwise permitted by the Principal.
 Students must adhere to the College regulations regarding their personal appearance as stated
 in the Rules for Uniform and Appearance.
- All items of uniform should be labelled with the student's name. Students who lose items of uniform should check Lost Property in the Dining Hall.
- All students must wear a blazer coming to and going from the College.
- Heels on shoes should be a maximum of 3 cm. Only black laces are permitted.
- Black denim-type jeans are not acceptable. If students wish to wear a belt, it must be plain black.
- Subtle make-up is permitted in Year 10-14. Nails should be natural in colour.
- Only school appropriate hairstyles are permitted. Any student who requires further direction about what is an appropriate hairstyle must consult his/her Head of School before any changes are made.
- For health and safety reasons, long hair must be safely tied back for work in a Science laboratory or Technology workshop. Students may wear one plain ring and/or a plain pair of studs/ sleepers (one in each ear lobe). Nose piercings and other piercings must be replaced with a clear stud during the school day. No other jewellery may be worn. Jewellery must be removed during PE classes. Students who wish to have new piercings should therefore do so at the beginning of the summer holidays.
- All Upper School students must wear the Sixth Form crest on their blazers.
- Any item of clothing or jewellery worn against College uniform regulations is liable to be confiscated, to be returned at the end of the school day.
- An explanatory note from a parent must be provided if a student cannot wear College Regulation Uniform.
- The College reserves the right to issue further guidance to students during the school year in the event of fashion trends impacting adversely on student appearance.

These rules are subject to amendment by the Principal. In all cases, the Principal reserves the right to apply what she considers to be the most appropriate sanctions in relation to non-compliance with College Uniform Policy.

8. Extra-Curricular Sport

- Students who are selected to represent the College in extra-curricular sport must wear College Regulation PE Uniform. Students who do not adhere to the above will not be permitted to represent the College.
- If students are involved in a sporting activity at the beginning of the school day, they may come
 to school in their College tracksuit and change into College Regulation Uniform before returning
 to class.
- Students returning home after extra-curricular sporting activities are permitted to wear either College Regulation Uniform or College Regulation PE Uniform.
- It is strongly recommended that mouth guards are worn for camogie, Gaelic and hurling.

9. <u>Inclement Weather</u>

- In inclement weather a plain black coat or a black/grey woollen hat may be worn whilst travelling to and from the College and then removed on entering the school building.
- Students are encouraged to wear additional layers under their school shirt/blouse.

10. <u>Safe Travel: High Visibility Items and/or Reflective Panels</u>

School uniforms can often be quite dark, making it difficult for students to be seen by drivers during the winter months, particularly on rural roads when travelling to and from school.

Parents are asked to ensure that students wear high visibility items and/or reflective panels on their schoolbags when making their way to and from the College.

11. Roles and Responsibilities

Students are expected to take pride in their appearance as representatives of Our Lady and St Patrick's College, Knock. When in uniform, all students are ambassadors of the College and it is important that they adhere to school uniform standards in the College, going to and from the College and at all College functions and representative events.

The Student Council, Mentors, Senior Prefects and Head Team are role models for the student body. They are responsible for upholding high standards of uniform and representing the views of the students of Knock.

College Staff are responsible for upholding high standards of uniform. They should record poor uniform standards as per College procedures and refer any student whose uniform is persistently unsatisfactory to the Tutor.

Tutors/Heads of Year/Heads of School/Vice Principals have particular responsibility for maintaining high standards of uniform in their respective groups and apply sanctions as appropriate.

Parents/Carers are expected to ensure that their child wears full College uniform and abides by College rules. Close cooperation between home and school is essential in order to maintain high standards of uniform. Parents are reminded that on accepting a place for their child(ren) in the College, they were advised that it is our expectation that parents support College staff when they implement College policies.

12. Exceptions on the Grounds of Religious Beliefs, Race or a Medical Condition

Deviations from these regulations on the grounds of religious beliefs, race or a medical condition may be permitted. For instance, students with a skin condition may be unable to wear certain materials or someone with a broken limb may require a temporary exemption.

If the adjustment is not a previously agreed change, a request should be made in writing to the Vice Principal (Pastoral Care) for consideration. Individualism is not an acceptable reason to depart from the regulations.

13. Non-Compliance with College Uniform Policy

Where a student is not adhering to College Uniform Policy, the Pastoral Team will make discreet enquiries as to why this is the case and provide assistance if required.

If there is no valid reason, designated staff have authority to sanction students for unacceptable standards of uniform in school and, in some circumstances, outside school. Infringement of College uniform regulations will result in the issue of a sanction in line with the College's Positive Behaviour Policy.

The Vice Principal (Pastoral Care) will review this Uniform Policy every three years in consultation with the Student Council, parents and staff.
